ADMINISTRATIVE ORDER
95-3

WHEREAS, it has been determined that a need exists to more effectively coordinate training issues related to the Mohave County Court Automation Project among all courts and to ensure development of uniform software tables and standardized court user codes; and

WHEREAS, the Mohave County Judiciary intends to maintain consistency, to the extent possible, with such tables and codes developed in Pinal and Yavapai Counties; and

WHEREAS, the Mohave County Court System will need to establish additional software codes and/or eliminate or revise existing codes based upon court use of the Progressive Solutions, Incorporated (PSI) FACTS application and resolve user software issues in the future; and

WHEREAS, it is necessary that a software user manual with such tables and codes be prepared for documentation purposes and the training of new judges and court staff;

IT IS ORDERED that the Mohave County Court Automation Project User Group be established which shall be responsible for meeting the above objectives and other software-related project issues as needed.


